Vendor Information & Festival Guidelines

The Fin and Feather Fall Festival welcomes artists, craftspeople and selected vendors from across the United States. The Festival is held on the grounds of Fin and Feather Resort in eastern Oklahoma, with exhibit areas in three permanent buildings and individual outdoor spaces. Onsite dining and lodging are available.

APPLICATION & SELECTION

Application fee: There is no application fee. Do not send booth payment with your application. Booth fees are due only after acceptance and requested.

New application each year: All vendors must submit a new application for the 2027 show. Applications are not automatically carried forward from prior years.

Photos required: Include at least 5 clear photos showing the types of products you plan to sell and your overall booth display. Photos may be used in Festival advertising. Applications without photos cannot be considered.

Acceptable work: Preference is given to artists and makers with handmade items. Some purchased-for-resale items may be accepted. Distributor items are seldom accepted. Commercial promotional booths are not accepted unless specifically approved.

Selection: Vendors are selected based on product quality, uniqueness, presentation, category balance, available space and the Festival's needs. Final selection and placement decisions are made by Festival management.

Three-day participation: Acceptance is for the full three-day Festival. Exhibitors are expected to staff their exhibits for the duration of the show, rain or shine.

RETURNING VENDOR SPACE PRIORITY

Vendors who participated in the 2026 Fin and Feather Fall Festival have first option to request the same booth location for 2027. To receive that consideration, indicate that you are a returning vendor and list your 2026 building/area and booth number(s) on the application. Every effort will be made to honor the request, but exact placement cannot be guaranteed if operational or space changes are necessary.

BOOTH SPACE & DISPLAY

Indoor booths: Carriage House spaces are approximately 8 x 6 ft. Fin Bin and Great Hall spaces are approximately 6 x 8 ft.

Outdoor booths: Outdoor spaces are approximately 10 x 10 ft. Outdoor exhibitors provide their own tents, weights, tables, chairs and display equipment.

Display furnishings: Exhibitors provide racks, shelving, backdrops, table coverings and other display fixtures. All table coverings should extend to or near the floor for a finished appearance.

Rental tables: Subject to availability: one 8 ft table for a Carriage House booth or one 6 ft table for a Fin Bin or Great Hall booth may be rented for \$25 each.

Food vendors: Include your complete proposed menu, footprint/size requirements and clear photo(s) of your setup with the application.
